1. 13/0046/OUT ALPC meeting 13/02/2013

Land At Cayford House (Eric Shepherd Unit) And Sunnyside And Crossways Woodside Road Abbots Langley Hertfordshire WD5 0HT - Outline Application: Demolition of Crossways and Eric Shepherd Unit and redevelopment to provide 12 houses and 8 affordable flats with associated access (appearance, landscaping, layout and scale reserved - resubmission of 12/1446/OUT) for Hertfordshire Partnership NHS Foundation Trust.

**ALPC Comment:** Members object to this proposal considering it to be overdevelopment on the site. They are concerned about insufficient parking resulting in overspill parking on the very busy Woodside Road; the loss of trees including some with TPO's and the effect of the height and bulk of the 'non aspect' brick wall of the proposed flats on the properties in Harlech Road, especially numbers 76 and 78. Members feel the footpath between 82 and 84 Harlech Road should be fully metalled and made a public right of way in perpetuity. The Parish Council requests that this application is referred to Committee for their consideration unless Officers are minded to refuse the application.

**ALPC Comment:** If this was a new build two storey property a 1.2m gap to the boundary would be required. As a conversion this gap has not been allowed for in the plans, creating possible boundary overhang problems. Members object due to lack of boundary.
