Reason: The proposed dormer windows, by virtue of their design and siting, and ground floor extension, by virtue of its design, siting and materials, would appear as incongruous additions which would not respect the character of the host property or street scene and would be excessively prominent within the street scene and harmful to the character of the host dwelling and visual amenities of the area. The development would therefore be contrary to Policies CP1 and CP12 of the Core Strategy (adopted Oct 2011) and Policy DM1 and Appendix 2 of the Development Management Policies LDD (adopted Jul 2013).
