Garage Block Austin Villas Woodside Road Abbots Langley Hertfordshire - Demolition of existing garage block and erection of two detached chalet bungalows with accommodation in roofspace and associated parking and landscaping for Mrs Audrey Balderstone.
ALPC Comment: Members feel their original objections have been partly addressed but still have concerns about the access onto a busy road.
TRDC Decision: Approved

64 Station Road Kings Langley Hertfordshire WD4 8LB - Single storey rear extension for Mr and Mrs Berdinner.
ALPC Comment: No objections.

Ruslings Hamilton Road Hunton Bridge Kings Langley WD4 8PZ - Single storey front extension. Alteration to roof including raising of ridge, front and rear dormers and lifting of side and rear walls to create first floor accommodation, extension of front parking area and widening of dropped kerb for Mr & Mrs S Pattison.
ALPC Comment: No objections.

ALPC Comment: No objections.

128A Toms Lane Kings Langley Hertfordshire WD4 8NR - Replacement pitched roof over existing flat roofed rear extension for Mr Kieran Corcoran.
ALPC Comment: No objections.
TRDC Decision: Refused
Reason: The proposed replacement pitched roof over the existing flat roofed rear extension would by reason of its scale, bulk and massing lead to a dominant and obtrusive form of development to the detriment of the open character and appearance of the Metropolitan Green Belt and visual amenities of the streetscene. The size and scale of the development would result in a development disproportionate in size to the original dwelling resulting in an inappropriate form of development in the Green Belt. No special circumstances exist to outweigh this harm. The proposed development would be contrary to Policies CP1, CP11 and CP12 of the Core Strategy (adopted October 2011) and Policies DM1, DM2 and Appendix 2 of the Development Management Policies LDD (adopted July 2013).

- 2 Heather Close Abbots Langley Hertfordshire WD5 0SS - Replacement of existing attached garage with two storey side and rear extension with rear dormer window and single storey rear extension for Mr Colin Fewster.
- ALPC Comment:** Members are concerned about the lack of parking provision, which is an issue on this estate, as the garage shown on the proposed plans is too small to accommodate a car. Also any trees removed must be replaced.

- 40 Dowding Way Leavesden Watford Hertfordshire WD25 7GA - Part retrospective: Retention and re-siting of existing air conditioning unit along side elevation of dwelling for Mrs Valerie Fraser.
- ALPC Comment:** No objections providing the re-siting of the unit addresses the noise problem.

- Rose Acre Barn Bedmond Road Pimlico Hertfordshire - Construction of detached building to serve as a carport, log store and cycle/mower store for Countryfile Ltd.
- ALPC Comment:** No objections.
- TRDC Decision:** Refused
- Reason:** The proposed development, by virtue of its siting, size and scale, would result in the spread of urbanising development throughout the site and introduce a prominent form of development within the landscape, to the detriment of the openness of the Metropolitan Green Belt. Furthermore, the scheme would be an inappropriate form of development within the Metropolitan Green Belt. No very special circumstances exist to outweigh the harm to the Green Belt and as such the proposal is contrary to Policy CP11 of the Core Strategy (adopted October 2011), Policy DM2 of the Development Management Policies LDD (adopted July 2013) and the National Planning Policy Framework.
9. 14/2121/LBC ALPC meeting 19/11/2014
- 3 Dairy Way Abbots Langley Hertfordshire WD5 0TB - Replacement windows for Mr Goldstein.
- ALPC Comment:** Members would prefer replacement wooden frames on this Grade II listed building in the green belt, but providing the PVCu replacements look the same as the existing wooden ones they have no objections.
- TRDC Decision:** Refused
- Reason:** The proposed uPVC windows would fail to respect the character of the existing materials and would appear contrived and result in harm to the character and significance of the existing Grade II Listed barn. No justification has been provided for the change of materials to the existing windows and there would be no public benefits as a result of the proposal that would outweigh the harm the alterations would have on the significance of this Grade II Listed Building. As such, the proposed uPVC windows would be contrary to Policy CP12 of the Core Strategy, Policy DM3 of the DMP LDD and the requirements of the NPPF.
