Despite a few previous spates of theft from motor vehicle and vehicle interference offences we have not seen a further large scale repeat of this and we are actively tackling this through our Project Insecure. This involves Abbots Langley Safer Neighbourhood Team going out on mass and trying car door handles to identify insecure vehicles. If vehicles are

insecure we are then speaking with the owners and providing crime prevention advice. Far better for us to find the vehicles insecure than a criminal!

We have had a few vehicles stolen over the last few months which have predominantly been keyless car thefts which is a national issue and not something unique to Abbots Langley.
